Duties of the Public Relations Officer

The Public Relations Officer shall:

- be responsible for the publicity of the Forum or Board, its activities and successes;
- facilitate the communication between the media and the Forum or Board;
- ensure that there is adequate community participation in activities of the Forum or Board;
- be responsible for the communication strategy of the Forum or Board;
- · keep record of all media and community coverage;
- liaise with the SAPS counterparts to keep each other informed of media statements and enquiries relating to the Forum or Board;
- only communicate on behalf of the Forum or Board with the authority of the Executive;
- No statutory member may be appointed as a Public Relations Officer for the Forum or the Board;



Victim Empowerment Programme

- Victim Empowerment is a national priority with all Government departments working in partnership with Non Governmental Organisations (NGO's) and Community Based Organisations (CBO's) to improve services to victims of crime and violence.
- Victim Support Programme is an important part of any Victim Empowerment Programme which usually provides; emotional support, and referral to other counselling services if required.
- The Department of Community Safety, South African Police Service, Western Cape Community Police Board, Business Against Crime and SPAR have taken an initiative to work in partnership, and are proud to have played a central role in developing the Community Based Victim Support Programme and establish victim friendly facilities and volunteer networks at police stations.



Victim Empowerment Programme

What is Victim Empowerment?

Crime violates the Human Rights of a Victim.

Often the Human Rights of the victim have been forgotten -now is the time to set that right

- a. A victim is anyone who has suffered harm or loss as a result of crime.
- b. Victim Empowerment is about making it possible for a victim of crime to heal and move on from the crime with the least possible harm or loss.
- c. It is the process of making sure that the victim is empowered to contribute to a process of restorative justice, by entrenching internationally accepted basic victim's rights as agreed by the United Nations



Victim Empowerment Programme

Responsibilities of VS Volunteer Coordinator

- a) Report to VSMC, CPF, and Provincial VS Coordinator re VS scheme
- b) Recruitment of volunteers
- c) Arranging VS training for volunteers
- d) Arranging & attending monthly supervision & debriefing of volunteers
- e) Managing & supervising the volunteers
- f) Managing the duty roster of volunteers
- g) Liaising with service providers & referring victims appropriately
- h) Admin, record keeping & statistics
- i) Managing VS Room with SAPS VEP Officer
- j) Attending SAPS station & CPF meetings
- k) In consultation with VSMC, launch public awareness campaigns and market service



Expanded Partnership Programme

This is a flagship programme of the Western Cape Government, Department of Community Safety.

The EPP is aimed at:

- Increasing the efficiency and sustainability of CPF's in the Western Cape Province;
- Promote civilian oversight over the local police;
- Providing a funding model to sustain CPF's with regards to implementing crime prevention awareness, campaigns, projects;
- > Strengthening the CPF to focus on its core business;
- > The setting of minimum standards of service delivery;
- > Providing an early alert system that will identify problem solving matters; and
- Keeping the police accountable to the local safety needs.

The EPP intends to promote the activities and functions of CPF's, building strong civil society structures which is critical to the success of safer communities.
